**~~[PROPOSED]~~ ORDER DISSOLVING ASSET FREEZE AS TO RELIEF DEFENDANTS
SHARON NUNAMAKER AND SDH DESIGN, LLC**

WHEREAS the Securities and Exchange Commission (the “Commission”) filed this action on January 20, 2017, against defendants Dwayne Edwards (“Edwards”), Todd Barker, Senior Solutions of Social Circle, LLC, Oxtan Place of Douglas, LLC, d/b/a Oxtan Real Estate of Douglas, LLC, Rome ALF, LLC, Savannah ALF, LLC, Gainesville ALF, LLC, Waterford Place ALF, LLC, Montgomery ALF, LLC, Columbus ALF, LLC, and Opelika ALF, LLC, and relief defendants Oxtan Senior Living, LLC, Manor House Senior Living, LLC, Susan Edwards, Sharon Nunamaker (“Nunamaker”), and SDH Design, LLC (“SDH”);

WHEREAS the Commission filed an emergency application for an order to show cause, temporary restraining order, preliminary injunction, asset freeze, and certain other relief (the “Emergency Application”) on January 20, 2017, the same day it filed this action;

WHEREAS, following a hearing on the Emergency Application, on January 20, 2017, the Court entered the Order to Show Cause, Temporary Restraining Order, and Order Freezing Assets and Granting Other Relief (ECF No. 8) (the "Order");

WHEREAS, pursuant to Paragraphs X and XI of the Order, the Court froze the assets of Edwards, Nunamaker, and SDH;

WHEREAS the Court extended the asset freeze in the Order, as well as all other temporary restraints, by subsequent orders dated January 31, 2017 (ECF No. 17), and February 22, 2017 (ECF No. 67); and

WHEREAS the Court has entered a final judgment as to Nunamaker, and the Commission staff have filed a stipulation of voluntary dismissal as to SDH;

ACCORDINGLY, IT IS HEREBY ORDERED THAT the asset freeze contained in the Order is dissolved as to Nunamaker and SDH only.
