PLEASE TAKE NOTICE that, on July 20, 2020 at 9:00 a.m., or as soon thereafter as counsel may be heard, the undersigned will move before the Honorable Esther Salas, United States District Judge, at the United States District Court of the District of New Jersey (the “***District Court***”), Martin Luther King, Jr. Federal Building, 50 Walnut Street, Newark, NJ 07102, for the entry of the proposed *Order Approving Waller Lansden Dortch and Davis, LLP’s Final Fee Application for Compensation for Services Rendered and Reimbursement of Costs and Expenses Incurred as Counsel to the Receiver for the Period From October 1, 2016 Through June 26, 2020* (the “***Final Waller Fee Order***”).

Unless an Objection is timely filed and served by the Objection Deadline, the Receiver shall request entry of the Final Waller Fee Order.
